Rules and Regulations

- Class size is limited and on a first-come, first-serve basis. Registration is required.
- Registration and payment must be received before camp begins.
- Due to the volume of registrations received, Prompt & Play does not send registration confirmations in the mail. Please plan to attend your session unless you are notified otherwise.
- If the program or session you have registered for is full, you will be notified by phone so you may choose another session, be placed on a wait list or request a refund.
- Only registered and paid individuals may participate in class activities.

Cancellation Policy: The \$125.00 deposit per week is non-refundable if camper chooses not to attend camp. It may be applied to an alternate week if chosen with a two week notice.

Weekly trips and pool outings: Charges for our weekly trips and outings to the pool will be due the week of camp and can be charged to the credit or debit card on file if requested.

Late pick-ups past 3:05 PM will be charged our before / after care fee of \$25.00 per hour, billed in 15 minute increments to the credit or debit card on file.
